Criminal Damage

Officers were called to a school district building on South Ave for a report of criminal damage to a building. Dispatch stated the complainant has video cameras and possibly has one of the individuals identified. It appears from the damage, the three juveniles took some bricks from a fenced in area and threw them at the garage door and light on the garage as well as the side of the garage. According to the maintenance manager he believed the damage would exceed \$3000 to repair the shed. Investigation continues.

OWI 4th & Fire

Officers were called to Hwy 53 at 50th Ave overpass for the report of a vehicle crash with one of the vehicles on fire. While in route, other Officers on scene advised one of the drivers fled the scene. Witnesses on the scene stated the driver fled after the crash. Officers located him and he was taken into custody for OWI 4th. A search of the driver's bag was conducted and methamphetamine and fentanyl residue was located. He was taken to jail for OWI and drug charges.

Juvenile Case

CHSO requested assistance in looking for a missing 4-year-old autistic child. It was believed the child went into a cornfield. CFPD began to respond with the drone; however, the child was located before we arrived.

911 Misdial

Caller reported he returned home from the gym and his dog was excited to see him and grabbed his phone when he jumped on him causing the phone to dial 911. He confirmed there was no emergency and he did not need assistance. No issues observed by officers.

Sex Offence

Members of the Bikers Against Predators non-profit organization advised they were out with an adult male that attempted to meet with an 11-year-old female. Contact made with the complainant as well as suspect. The suspect was arrested for a probation hold, attempted child enticement, attempt to cause a child to view or listen to sexual activity, and use of a computer to facilitate a child sex crime.

Drug Abuse

Officer responded to a complaint. A bong and jar with marijuana shake in it was observed in plain view from the door. A female initially refused to exit, but eventually complied. No one else was at the residence. The homeowner/primary tenant and the female were both on probation for drug related offenses. An Act 79 search was conducted on the residence and additional items of police interest were located. The female was charged with Possession of Methamphetamine, Possession of Drug Paraphernalia, and Possession of THC 2nd. Charges for the male are pending.
