### Drug Abuse

An officer conducted a traffic stop on a vehicle with improper plates. During traffic stop, the driver was taken into custody for her warrants. During arrest, multiple drug items were located inside her purse. During the jail process, she spit out a plastic bag with white powdery substance. She was taken for medical clearance. Officers learned the plastic bag had fentanyl inside of it. She was arrested for her warrants, possession of methamphetamine, possession of narcotics, possession of drug paraphernalia, and felony bail jumping.

### Drug Abuse

Officer stopped a vehicle with a revoked driver. She was arrested for OWI-4th Offense, Possession of Cocaine, Possession of Drug Paraphernalia, Possession of Illegally Obtained Prescription, Operating While Revoked and taken to jail. The passenger was arrested for Resisting or Obstructing an Officer and Possession of Drug Paraphernalia and released on scene.

### Warrant

A woman messaged the police department Facebook page and reported she was at Kwik Trip, willing to turn herself in on her warrants. Dispatch confirmed she had multiple, valid warrants. Contact made with her and she was taken into custody and brought to jail.

### Warrant and Drug Abuse

An officer observed a man walk away from the Mystic Bar on Canal St. with an active warrant for child support. The officer contacted the man and arrested him for the warrant. He was transported to the Chippewa County Jail. A THC vape pen was located on him and an additional charge of possession of THC was included. The jail later advised they

had located a suspicious item in his property after he was booked in. The officer responded back to the Jail and was shown five gem-style baggies, all full with a white powdery substance suspected to be cocaine that had been in his possession. An additional charge of felony intent to deliver cocaine was added.
