## **Domestic Abuse**

Caller reported her adult son being beaten by her husband. Officers learned that the father shoved the son twice knocking him to the ground. The caller heard her son screaming for help and contacted law enforcement. The father did not deny the altercation and admitted to shoving his son. The son advised he feared his father and thought he was going to kill him. There has been a history of violence when he drinks and he has physically struck both the mother and son before. He was taken into custody for disorderly conduct with domestic abuse enhancer and booked into the Chippewa County Jail. Due to statements made about returning to the residence upon release and statements of fear of being killed or bodily harm made, Officers requested he be held to see a Judge.

## Miscellaneous

Delivered 747.84 pounds of expired or unwanted prescription drugs collected over the last 6 months from drug drop boxes in Chippewa County.

## **Disorderly Conduct**

Officers responded to the area of Burger King for a report of an impaired driver. Officers checked the area and located the silver vehicle described by the complainant. Caller reported the male had entered the business and caused a disturbance by asking customers for marijuana and showed signs of impairment. Officers located the vehicle near Spring St and Bridge St with the driver side window open with the keys inside the ignition. The owner was not located. Keys were taken to PD and vehicle cited for Keys in Unattended Vehicle. Later the owner came to the PD and took possession of his keys. He denied asking for drugs but said he had talked about someone who had smoked in the past. The officer

did not observe impairment. He was verbally warned for his behavior and released. He stated he understood the reason behind the parking citation to help prevent auto theft.

## **Drug Abuse**

Officers received a report from staff at America's Best Value Inn that there were two small children who were running around the lobby area advising they could not wake up their mom. Upon arrival officers were able to wake up the mother and a male subject in the room. Officers contacted DHS and made arrangements with the children's grandmother to come and take the children back to her residence. The mother was arrested for possession of cocaine and possession of drug paraphernalia.
