Resisting

An anonymous report of a physical domestic in progress between a male and female. Officers made contact with the two. While the male was being detained, he began to resist officers. A taser was directed at him but given his clothing attire, he was directed to the ground and handcuffed. He was arrested for Felony Bail Jumping, as he was intoxicated and on a "no-drink" bond, and Resisting or Obstructing an Officer. The physical domestic was investigated and found to be unsubstantiated.

Overdose

Complainant reported a heroin overdose at a downtown apartment building. Contact made with a female at the apartment. Officers located an unresponsive male on the living room couch and he was transported via ambulance to St. Joseph's Hospital. The female admitted to snorting the same substance the male had and was transported via ambulance to St. Joseph's Hospital for medical evaluation.

Drug Abuse

An officer noticed what appeared to be drugs in a parked and unoccupied vehicle. A traffic stop was later conducted, and through investigation a search was conducted locating almost 30g of methamphetamine. The driver was arrested for Possession with Intent Methamphetamine and a probation hold was placed.

Mental Health

Officers were called to a park for the report of a female attempting to commit suicide. Upon his arrival he made contact with the female who cut her arm. The officer was talking to her when she suddenly attempted to jump into the river. The officer stopped and then detained her. Northwest Connections was contacted and an emergency detention was put into place and she was transported to a hospital.

Drug Abuse

An officer conducted a traffic stop for speeding. The driver was discovered to have an active warrant. A search was later conducted on the vehicle. The driver was arrested for the warrant, possession of THC, possession of LSD, and carrying a concealed weapon. She was taken to jail.
