Weapons and Operating a motor vehicle without owner's consent

Officer made a traffic stop on a stolen vehicle. The driver was arrested for Operating motor vehicle w/o owner's consent, felon in possession of firearm (pistol), carrying a concealed knife, and a Probation hold.

Domestic Abuse

Officers were advised to respond to the area for a male who was yelling for help. Officers followed a blood trail from the vehicle to a residence on Terrence St. Officers looked in through the window and observed a male on the ground bleeding. Contact was made with three people including a male. He refused to identify himself and cornered Officers telling Officers to leave. He was eventually identified and transported to jail for Disorderly Conduct and resisting. A probation search was completed of the vehicle and a bottle of alcohol was located.

Drug Abuse

Officer conducted a traffic stop on a vehicle because the registered owner has a revoked license. SFST's were conducted and negative impairment was observed. A PC search was conducted and she was arrested for Possession of Cocaine 2nd Sub. Offense, Possession of THC, Possession of Drug Paraphernalia and Felony Bail Jumping.

OWI 5th

Anonymous report of a male leaving Prevea in a vehicle and being intoxicated. Contact was made with him at Mega Holiday. Evidence of intoxication was present. SFST's were attempted and he was arrested for OWI 5th.

Fraud

Caller reported a fraud where a total of \$13,000 was stolen from him when he received an email from a fake Paypal account where it had an attached PDF stating there is an invoice for an order of \$870.99. Caller contacted the number listed in the email and spoke to an "Ed Lewis" from the fake fraudulent department of fake Paypal. Caller reported he was asked to obtain \$13K of gift cards because he was told they needed gift cards to setup a trap for the "guys" to be caught and once they were caught Paypal would refund the 13K back. Caller was put into contact with the CFPD financial crimes investigator to follow up.

Fraud

Caller wanted to report a fraud from someone he met online. Caller met a female online who requested money for paint. Caller reportedly sent the female \$1,300 dollars for paint when he was contacted by the female's manager. The manager told Jesse he sent him \$25,000 dollars which was actually a loan taken out in Jesse's name. The manager requested an additional \$2,000 dollars from Jesse for art fees. The manager requested the remainder of the \$23,000 dollars when Jesse contacted Law Enforcement. Caller then reported to the CFPD that he was speaking with "Sgt. Adam Alix" with the "Chippewa Falls Police Department". Caller said "Sgt. Alix" had a heavy southern accent and told him to call back within 24 hours. Caller was advised that we did not have a "Sgt. Adam" at the Chippewa Falls Police Department and to block the number he was messaging. Caller was provided options on how to deal with the \$3,000 loss he had incurred.

OWI 2nd

Staff at Royal Credit Union reported a confused male, possibly under the influence, in their lobby. Officers spoke to a male, who said he drove to the bank. He was seen on video driving into the parking lot and walking in. He was eventually taken into custody for operating while impaired (2nd offense), operating while revoked, and fail to install an Ignition Interlock Device.
