2nd Degree Reckless Endangerment/Reckless Driving/Felony Criminal Damage

Officers responded to Irvine Park for a report of a blue van with out-of-state plates driving into the fences and Christmas decorations. Dispatch advised an Irvine Park employee had parked their truck in front of the van to stop it. The van began to ram into the truck. Officers arrived and removed the female driver from the vehicle following a high risk stop. She was arrested and transported to CHSO Jail.

OWI Crash with Injury

Officers responded to a one-vehicle crash on STH 178/Cashman Dr. The vehicle left the roadway and struck a power pole. The driver suffered a suspected head injury and was transported. The driver left work and fell asleep driving.

Assist Non-Law

Chippewa County DHS requested Therapy Dog Chip assist with a home visit in relation to a previous case involving child abuse. Juvenile was removed from his father's care and placed with his mother. Juvenile has recently been bullied at school and has had a lot of anxiety of returning to his dad's care in the future.

OWI & Property Damage

Officers were dispatched to a report of a one-vehicle crash that struck a power pole. Officers arrived and located the vehicle hit a power pole, breaking it completely off and there were low hanging live wires. Officers contacted the driver and he showed signs of impairment. The driver was transported by EMS. It was determined he was traveling northbound on Main St from Sweeny's Bar where he went through the intersection and jumped the curb. He then rode the curb until he struck the power pole. SFST's

conducted and impairment was observed. PBT of .16. He was arrested for OWI 1st and failure to maintain control of the vehicle.

Drug Overdose/Abuse

Officers were dispatched for an unresponsive male. Officers arrived on scene and were allowed into the apartment by the complainant. Officers observed a male subject slumped over on a chair, unresponsive. The male was identified. EMS administered Narcan and he regained consciousness. Officers observed a glass pipe with white residue underneath his chair and a blue vile with a white rocky substance attached to a lanyard on his neck. He was placed into custody without incident.

Drug Overdose Death

A male subject reported his girlfriend had overdosed. He let officers inside the upstairs apartment and she was located deceased. Several items of illicit drugs were located around the female. Alcohol was seen around the male's downstairs apartment. He is on open felony bond not to possess alcohol. He was referred for bail jump charges.

Firearm Investigation – Self-Inflicted Gunshot

Officers were called to St. Joes Hospital for a report of a male who accidentally shot himself while cleaning his gun. Officers arrived and contacted the male. He stated he has a revolver pistol he conceal carries when he is not working. He told officers he was loading the pistol and, upon placing it back in the holster, the gun went off, striking him in the leg. Upon investigation, nothing suspicious observed.
