Drug Abuse and Weapons

Officers saw a male who they recognized and suspected of violating his felony bond restrictions. The male had left his vehicle and walked away on foot in what appeared to be an attempt to elude officers. The officers were able to locate him and take him into custody. A K9 sniff of his vehicle was conducted. After a positive indication, meth and a pistol were located in the vehicle. He was brought to jail for felony bail jumping, possession of methamphetamine, and possession of drug paraphernalia.

Harassment

Caller reported he had texted and "voice messaged" her over 140 times within 2 days, violating a temporary restraining order. After also learning he took out a life insurance policy on her, this caused her to fear for her safety. Officers responded to Altoona, where he currently resides, and took him into custody along with assistance from Altoona PD.

Juvenile Case

Report of an out of control juvenile at a residence. The juvenile was also involved in an alleged school threat. Officers arrived and the juvenile needed to be detained and restrained. The juvenile made comments of self-harm, threatened officers and spit on the officers. The juvenile was evaluated by NW Connections and a safety plan was put in place. School threat was deemed not credible. The juvenile will be referred for threats to Law Enforcement, discharging bodily fluids, resisting officers, criminal damage and disorderly conduct.

Drug Abuse

Officer conducted a traffic stop on a vehicle. The driver was subsequently arrested for OWI as well as for possession of methamphetamine and operating while impaired. The passenger was arrested for possession of schedule II drugs, possession of methamphetamine, possession of cocaine, possession of THC, and possession of illegally obtained prescription.

Drug Abuse

Gas station staff reported a male slumped over behind the wheel of his vehicle for approximately an hour. Officers spoke to the occupant who appeared to be under the influence of illicit drugs and admitted to using methamphetamine recently (within 3 days). A consent search was granted and officers located methamphetamine and drug paraphernalia. He was taken to jail.
