Warrant Arrest

A caller reported seeing a man enter the back door of her residence. Caller wanted him removed and was fearful of him due to a previous domestic disturbance that occurred approximately a month prior. While officers maintained a perimeter, they observed the front door open and quickly close. Officers received permission from the owner to enter and clear the residence. They flipped over the living room couch and located the man hiding underneath. He was arrested for a DOC warrant and Obstruction.

Public Relations

K9 Leo was requested to drop the puck at the Chippewa Steel Game. Leo did well at dropping the puck.

Armed Robbery

Caller reported 3 men broke into their apartment and struck her and another tenant with a handgun and threatened to kill them. The suspects stole items from the residence. The suspects left in a black sedan. The victims were transported by EMS. Officers identified the suspects. Later that evening ECSO arrested one of the suspects and transferred custody to CFPD. He was booked into the jail on the following charges: Burglary- Armed with a Dangerous Weapon, Robbery-Armed with a Weapon, False Imprisonment, Intimidation of a Victim, Substantial Battery, Criminal Damage to Property, and Disorderly Conduct. The firearm believed to be used was recovered. Two more suspects have been identified and referred to the DA for party to the crime. Investigation continues.

Domestic Strangulation

Caller reported her boyfriend was being physically and verbally abusive. She reported that they had been arguing all day. During this argument he was slapping, hitting and pinning her to the floor. She had bruising around her eye and a swollen lip. He also reportedly put both of his forearms on her throat and applied pressure strangling her to the point she could not breathe. Officers located the boyfriend and he was arrested for Domestic Disorderly Conduct, battery, strangulation, carrying a concealed knife, and a DOC warrant.

Drug Abuse

Caller reported suspicious suspected drug activity from the downstairs neighbor. Contact was made with tenants. A blunt and marijuana shake were observed in plain view. Through the subsequent investigation the residence was searched and more evidence was located. One tenant was arrested for Possession of THC w/intent to Deliver, Illegally Obtaining a Prescription Medication, Possession of Drug Paraphernalia, (F) Bail Jumping, (M) Bail Jumping, Possession of a Masking Agent, Possession of Methamphetamine, and a Probation Hold. The other tenant was arrested for Possession of THC 2nd Offense, Possession of Methamphetamine, Illegally Obtaining a Prescription Medication, Possession of Drug Paraphernalia, and a Probation Hold.
