OWI 8th Offense

Officers observed a male subject slumped over the steering wheel of a vehicle. The officer knocked on the window multiple times and he was not responding. Eventually, he woke up and looked at the officers. The officer gave commands for him to open the door and come out. SFST's were conducted and he was arrested for OWI-8th Offense.

Drug Abuse

Report of a white van with two passengers going through a dumpster at the above location. Contact was made with a male and female. The male advised he had permission to go through the dumpster which was confirmed by a worker on site. Contact was made with the owner of the vehicle. The vehicle owner advised no one has permission to use his vehicle. A search of the vehicle produced drug paraphernalia. The male was referred for felony bail jumping, possession of methamphetamine and possession paraphernalia. The female was referred for possession of methamphetamine and possession of drug paraphernalia.

OWI 3rd and Drug Abuse

Staff at Kwik Trip reported a driver asleep at the wheel and the vehicle was running. Upon investigation the driver refused field sobriety tests and was arrested for OWI 3rd. Strong odor of marijuana was emitting from vehicle and a PC search was completed. Search yielded multiple items related to drug paraphernalia, organic green leafy substance inside a container, THC vape pen and two clear gem style baggies containing crystalline like substances. One bag had two

crystalline rocks which later tested presumptively positive for methamphetamine. She was transported and booked into the Chippewa County Jail under the following; possession of methamphetamine, possession of THC, possession of drug paraphernalia and OWI 3rd.
