### **Disorderly Conduct**

At the Chippewa Falls Middle School a student became upset with the lunch options. The student jumped up onto a set of lockers and proceeded to threaten to kick/throw a Chromebook at staff. The student proceeded to destroy 4 sound barrier pads that hang down from the ceiling along with two fire extinguishers. Eventually the student's mother was able to convince the student to get off of the lockers. The student was sent home for the day and will be referred to juvenile intake for Disorderly Conduct and Criminal Damage to Property.

### **Domestic Abuse Strangulation with a Firearm**

Officers were dispatched to a residence for the sound of a possible physical disturbance. Caller reported her boyfriend had come home and saw that she was talking to another male. He cornered her in the kitchen and head butted her causing her nose to bleed. He then threw her to the ground and choked her. Her two young daughters were present in the room for the incident. Officers made contact with the boyfriend, who was intoxicated, who tried to leave the residence with a rifle down his pants. He was disarmed and arrested for Domestic Disorderly Conduct, Battery, Strangulation, and being Armed While Intoxicated. The caller went to the hospital with her mother. The boyfriend went to jail.

### **OWI 7th**

Officer pulled over a vehicle that had a light out and was operated by a suspended driver. The driver appeared to have been drinking and had 6 prior OWI convictions. Field Sobriety Testing was completed and the driver was arrested for OWI 7th offense and taken to jail.

**Domestic Abuse and OWI**

Caller reported her boyfriend was at the residence and causing a disturbance. Caller said earlier while she was in Eau Claire he had called her 54 times and whenever she would answer he would scream at her asking who she is sleeping with. When she returned home he drove past the residence and then pulled into the driveway behind her. She ran into the residence and he followed her. She took her two children into the kitchen while he was still screaming at her. She said she was very scared and called 911. Officers talked to the boyfriend who was showing signs of intoxication. Field sobriety testing was conducted and he was arrested for OWI 2nd and taken to jail. He was also cited/referred for Operating after Revocation, open intoxicants in the vehicle, possession of drug paraphernalia, failure to install an Ignition Interlock Device, Possession of THC, and Domestic Disorderly Conduct.
