Disorderly Conduct (Vehicle)

Anonymous report of a black truck cutting off a white car. Contact was made with the driver of the car at his home and he stated that he was trying to move out of the way of the truck that was tailgating him. He stated that he moved 3 times and the truck followed. While speaking with the driver, the truck that was involved drove past officers. Officers were able to locate that truck and made contact with that driver who said that he kept getting cut off by the white car. Both parties warned about possible road rage. The driver of the truck was cited for having a suspended driving status and failure to install Ignition Interlock Device.

Drug Abuse

Officer made a traffic stop on a vehicle for defective brake lamps. Through investigation officers located a pen body that tested presumptively positive for Fentanyl. A search of the vehicle was conducted and additional Fentanyl and paraphernalia was located. The driver was referred for possession of Fentanyl. The passenger was arrested for felony bail jumping, possession of Fentanyl, possession of Methamphetamine, and possession of paraphernalia.

Drug Abuse

Officer made a traffic stop on a vehicle with a subject with a warrant. The subject was taken into custody and meth was found on him. A search of the vehicle led to the discovery of more meth, paraphernalia and prescription medication. Subjects were arrested for DOC warrant, Possession with Intent to Deliver Meth, Possession of Narcotics, Possession of Masking Agent, Possession of Illegally Obtained Rx, and Possession of a Controlled Substance.

Domestic Assault - Attempted Homicide

Officers responded for a report of a female who stated she had been shot. Officers provided first aid for the gunshot victim and secured the scene. Investigators processed the scene and searched for the suspect. Suspect turned himself in later that night. He was taken to jail for attempted homicide and other charges. Investigators located the firearm suspected to have been used. Investigation continues.

Mental Health

Officers responded to a male who was reportedly suicidal and armed with a large knife. Officers arrived on scene and detained the male. Upon speaking with the witnesses officers learned that the male obtained a knife and held it to his throat threatening to kill himself. He was interviewed and admitted to wanting to slit his throat. He was placed under a Chapter 51 commitment and taken to a hospital.
