Animal at Large

Caller located a dog named "Sunny" near the above location. She lured Sunny to her vehicle with a cheeseburger and brought him to the PD. The officer received the paper work from the humane association and spoke with the owner. The owner was from Menomonie and was assisting his son with home repairs when Sunny wandered off. Sunny was returned and the owner was warned on animal running at large.

OWI 5th with Weapon

Officer stopped a vehicle with a revoked driver and expired plates. Investigation led to an arrest for OWI 5th, OAR, fail to install Ignition Interlock Device, non-registration of auto, possession of methamphetamine, possession of drug paraphernalia, felony bail jumping (x3), probation violation, and carrying a concealed knife.

Drug Abuse

An officer was called to a car parked in the lot by the Excel Energy substation. The officer approached the vehicle and observed a male subject passed out in the driver seat and sweating profusely. The officer observed a zipper case with a white crystal-like substance and glass smoking devices in the center console. The subject woke up and drove off upon seeing Officers. A felony stop was conducted and he was taken into custody. Methamphetamine and paraphernalia were located in the vehicle. He was showing signs of impairment, refused fields and was arrested for OWI 2nd. He was booked into jail for OWI 2nd, possession with intent to deliver methamphetamine, possession of paraphernalia, and obstruction.

Pursuit

Officers responded for a warrant check. Officers observed a female walk to her vehicle. Before officers could address her, she entered her vehicle. Officers walked up to her driver's window and instructed her to exit the vehicle and then yelled at her to stop when she put the vehicle into drive. A pursuit was initiated. Officers pursued her to the dead end of W. Grand Ave where she ran on foot. Officers caught up to her and secured her in double locked handcuffs. She was booked into jail for her warrants, knowingly fleeing an officer, probation violation, 2nd degree recklessly endangering safety, possession of methamphetamine and possession of drug paraphernalia.

Drug Abuse

Officers were called for the report of a male who appeared to be passed out at the wheel on Prairie St. Officers arrived and contacted a male subject who was conscious and alert. He stated everything was ok and he wanted to take a nap in the vehicle. He appeared to be under the influence. A K9 was called to the scene. A positive indication from the K9 lead to a search of the vehicle where a scale with methamphetamine residue and pills were located. The subject was taken into custody for possession of methamphetamine, drug paraphernalia, possession of narcotic drugs, and felony bail jumping.

Check person

Report of a naked male pounding on the door of the above address. Upon arrival, contact was made with the man who made several nonsensical statements about everyone needing to take their clothes off and circle around him. He asked officers to turn their cars off and when he was told we could not do that he began approaching them stating he would do it himself. Due to safety issues he was detained. EMS arrived and he was transported to the hospital without further incident. Northwest Connections was contacted and it was believed to be drug-related and would follow-up.

Check Person

Officers observed a male and female being escorted out of the fairgrounds by security. Staff reported they had gone behind a restricted area and were told multiple times to leave but refused to do so. Eventually staff tried to escort them out however they were resistive and the female kicked staff. Staff did not want anything further done and requested they leave. Both subjects were escorted out of the fairgrounds.
