Check Person

Chippewa Falls Post Office worker noticed the front door to a residence had been open for days. Yelling could be heard from inside telling officers they could enter. Due to the buildup of garbage, rotting food, urine-soaked floors, and general living conditions, Adult Protective Services was contacted and made aware of the living conditions.

Fire

Fire and Law Enforcement were dispatched for a fire started in the train steam engine in Irvine Park. Fire Dept extinguished the fire that was started in the coal chamber. No damage was sustained to the steam engine. The area was checked and none of the cameras in the area caught the suspect.

Crash & OWI

Caller reported an employee had taken a company vehicle and crashed it somewhere near the above location. The suspected employee then got another company truck and attempted to

pull the first truck out of the ditch. The second truck then became stuck at the bottom of the steep embankment and damaged. Officers located the suspect unconscious in yet a third vehicle he had obtained. The suspect was arrested for OWI 1st offense. He did not have any injuries and refused EMS. Both vehicles removed by Jerry' s Towing.

Drug Abuse

Officer made a traffic stop for a vehicle with expired registration. Through investigation a search was conducted on the vehicle and the driver. The driver was arrested for Possession of Methamphetamine, Possession of THC, Possession of Drug Paraphernalia, Felony Bail Jumping, 6x Possessions of Controlled Substance and 6x Possession of Illegally Obtained Prescriptions.
