Domestic and Resisting

Caller reported her adult son made irrational statements such as the world was ending and he thought he was God. Also, the son had punched the father in the back of the head multiple times. Officer located and attempted to make contact with the man. He turned and approached the officer aggressively. The officer gave several commands to stop walking towards the officer and he did not listen. Pepper spray was used and he was arrested for Battery with the Domestic Abuse Enhancer, and Resisting an Officer. Northwest Connections was contacted and he was taken to jail.

Theft

An officer was on a traffic stop near the U-Haul store when he heard fireworks being set off for several minutes. Chippewa County Deputies overheard and advised that they were handling a case where fireworks were stolen. CFPD officers located several empty firework containers along with a vehicle which was registered to the suspect and had several fireworks inside the vehicle. The officer cited the suspect for Discharging Fireworks and Littering and CHSO investigated their theft case.

Fraud

Caller reported she's been in an online relationship via Google Chat with someone claiming to be actor Sam Heughan from Scotland since April 2022. She has sent him gift cards. It was explained about the logistics of investigating these types of cases. No bank information or social security number was provided. She was advised to block the accounts and provided options.

Weapons

Officer stopped a vehicle for expired registration. During the stop, the driver handed over THC. A PC search of vehicle was conducted and a concealed firearm was located. The driver was a convicted felon with past drug related convictions. Standardized Field Sobriety Tests were conducted and not enough impairment was observed. The driver was taken into custody without issue. Arrested for felony possession of firearm, carry concealed weapon, possession of THC and possession of drug paraphernalia. He was also cited for Non-registration of auto, warned for defective brake lamp and no proof of insurance.

Drug Abuse

Officer conducted a traffic stop on a vehicle driven by a female. Drug paraphernalia was seen in plain view and a subsequent vehicle search was conducted and drugs were found including THC, paraphernalia, cocaine, and methamphetamine. The driver was arrested for possession of methamphetamine, possession of cocaine, possession of THC, and possession of drug paraphernalia. The passenger was arrested for possession of methamphetamine, possession of cocaine, possession of drug paraphernalia and a Probation hold.
