Fire

Report of someone burning furniture near the above address. Upon arrival, furniture was observed being burned. Officer spoke with owner and he was unaware of the violation and would stop. He was warned.

Drug Abuse

Dispatched for a woman screaming in her room and not leaving after the checkout time. Officers met with the renter, who was speaking rapidly and talking about inanimate objects around her. Probation search was conducted on the room and 4.1 grams of Methamphetamine was located in the room along with drug paraphernalia. She was arrested.

Check Object

Caller reported he had a pipe bomb in his possession. Officers arrived and requested he place the bomb on the ground and walk away. Caller said his son located the bomb in the woods. Officers created a perimeter around the bomb and Marathon County Bomb Squad was contacted. Bomb squad removed the pipe bomb which was disposed at the CFPD range. Officers notified neighbors and searched the immediate area where the pipe bomb was located. A press release was also sent out.

Criminal Damage

Mailboxes on Wheaton Street were damaged. Unknown timeframe but likely took place during the night of 06/29/2023. Business cards left in damaged mailboxes with case number.

OWI 3rd

Complainant reports an occupied vehicle stopped in the traffic lane of Bridgewater/Jefferson, unknown if medical issue. Officers located the vehicle stopped in the roadway with the driver who was passed out with foot on the brake. He was arrested for OWI 3rd and felony bail jumping.

Warranty and Drug Abuse

A man was seen standing next to a vehicle and was recognized to have a warrant. Officers stepped out with him and took him into custody for the warrant. A crack pipe was observed in the vehicle he drove to the scene resulting in a vehicle search. Items located included crack cocaine, the crack pipe, multiple brillo-pad filters, and an airsoft bb container with white powder inside (cutting agent). He was arrested for felony and misdemeanor bail jumping, possession of cocaine, possession of drug paraphernalia, and his warrant.

Fire

Caller reported a vehicle fire in the southbound lane of 178. Officers arrived and saw a red mustang with the motor on fire. Fire arrived and put the fire out. The owner said the vehicle started to sputter so she stopped on the side of the road. The caller had passed by her vehicle and warned her that her vehicle was on fire. Vehicle was removed by Tilden auto.

Check Person

Dairy Queen Staff requested a check welfare on a man who has been sitting under the elephant for approximately 4 hours. An officer met with the man who said he was okay. The officer gave him a ride to Precision 1 Storage where he told the officer he lived. The officer stated he will be conducting follow up to find resources to help the man with his living situation.
