### **Warrant and Weapons**

Officer observed a vehicle known driven by a male with a probation warrant for his arrest. Contact was made with the man in the vehicle. When he was taken into custody the officer observed the handle of a large knife sticking out between the driver's seat and center console. He is prohibited from possessing concealed weapons and is on open felony bond. Charges for felony bail jumping and possessing concealed knives were added.

### Misuse of 911

Numerous 911 calls made throughout the day culminating in a threat to the high school. Investigators determined that the threat was not credible and that it had been a very young student who had made the calls. The student's behavior was addressed by the school and the parents.

### Warrant and Drugs

Officer conducted a traffic stop and the driver had a warrant for his arrest. He was taken into custody for a Chippewa County warrant. CHSO Deputy Bloom and his K9 partner conducted a sniff of the vehicle and yielded a positive indication. During the search of the vehicle drug paraphernalia and an open beer bottle were located. The driver was also charged with felony bail jumping.

# Drugs

Caller reported she wanted a male removed from her property. Contact was made with the male and a different female as they were pulling out of the driveway. The male turned over a vial of methamphetamine and tried to smash a pipe. A search of the vehicle yielded additional bags of meth, marijuana, and other items of interest. Both were arrested for Possession of Meth, Possession of THC and Possession of Drug Paraphernalia.

### Drugs

Staff reported a dark colored sedan with fogged windows parked in the parking lot next to a Dove Healthcare bus. Contact was made with the male owner and a female. A suspected meth pipe was observed in plain view in the center console. A gem bag was located on the male's seat when he exited the vehicle and one was located on the floor board. The male was arrested for Possession of Methamphetamine, Possession of Drug Paraphernalia, and Felony Bail Jumping. The female was arrested for Possession of Methamphetamine, Possession of Drug Paraphernalia, Felony Bail Jumping, and Misdemeanor Bail Jumping. The vehicle stayed on scene and the keys were placed in the female's property.

## Drugs

Officer conducted a traffic stop on a male driver with a suspended driver's license. The officer learned that the female passenger had an active EC County warrant. She was taken into custody for the warrant. During a search of the vehicle a small bag belonging to a different male was located in the vehicle. In the bag was a meth pipe, one-hitter style pipe, and bindle of suspected THC. That male was located near the Indianhead Motel taken into custody. Prior to being taken into custody he attempted to ditch a gem bag of suspected meth. A probation search of a motel room was conducted and additional items of police interest were located. The male was charged with Possession of Methamphetamine, Possession of THC 2nd, Possession of Drug Paraphernalia, and Possession Illegally Obtained Rx.

### **OWI and Weapons**

Officer saw a vehicle fishtailing on Main at River St. and then again on Main at Park Ave. The officer conducted a traffic stop on the vehicle. The driver admitted to drinking while playing trivia earlier that night. The driver also stated he had a gun in the center console. The driver was evaluated for intoxication and was arrested for OWI 1<sup>st</sup>. During a search of the vehicle an officer located a loaded firearm. He was also referred for carrying a concealed weapon and armed while intoxicated and take to jail.

### **Drug Abuse**

ECPD requested officers check the area for a vehicle. ECPD advised the vehicle was rented and had not been returned to their UHaul location. CFPD officers located the vehicle parked with a male asleep behind the wheel of the van. As he exited the vehicle a meth pipe fell from his lap. He was arrested for Possession of Paraphernalia, Methamphetamine, and bail jumping. The vehicle was delivered to UHaul.
