Weapons

Caller reported a male was at a local tavern with a gun. Due to call volume CHSO was requested to assist. A man was standing in the area with a pistol. Assist LE

A traffic stop was conducted with the suspect on Hwy 53. Negotiations were initiated, but he refused to exit the vehicle. SWAT arrived on scene and negotiations continued, but he continued to refuse to exit the vehicle. SWAT deployed chemical munitions and he exited the vehicle and was arrested. CFPD transported him to the jail and assisted with the interview.

Fight

SRO Downey was informed of a fight that occurred in the M.S. boys' locker room. A student was in the nurse's office. As school ended the student began to throw up and was taken to the ER. The suspect was located, interviewed and given school consequences as well as being referred for substantial battery.

Sexual Assault

A 16-year-old reported a homeless male approached him and his two friends, a 15-year-old another 16-year-old. The homeless man allegedly made sexual comments toward them, grabbed one child by the buttocks and another by the genitals. The man admitted to having a sexual type conversation but denied

the sexual contact. He was arrested for 2nd degree sexual assault of a child, 4th degree sexual assault, child enticement, disorderly conduct and taken to jail.
