Weapons

An officer observed two males apparently unconscious on a couch in the back lawn of a residence with smoke coming from a fire pit at 08:30am. The owner inside the residence said he did not know who the two males in his backyard were. The officer approached to check on their welfare. The officer observed a pistol and loose 9mm rounds on a footrest between a male's feet along with multiple opened beer cans. The officer woke up the males who told the officer they fell asleep while having a fire the night prior. The males were aged 17 and 22. Neither of them took ownership for the alcohol. The 17-year-old stated the pistol was his father's and he had it for protection. He appeared to be still somewhat under the influence of alcohol but was uncooperative with officers. He was referred for misdemeanor possession of a dangerous weapon under the age of 18, underage tobacco, and underage drinking. His mother was notified. The firearm was seized by officers and the owner notified to come pick it up.

Domestic and Drug Abuse

Report of a domestic between a male and a female in the parking lot of America's Best Value Inn. It was reported one party was trying to force the other into the vehicle. Upon arrival officers contacted the two parties. Through investigation it was learned that one of them made comments of self-harm and the other was trying to restrain them. No domestic assault was substantiated. They refused to speak to NW Connections. There was insufficient cause for an Emergency Detention. Both parties expressed frustrations about housing and concerns for their child. DHS was notified and will follow-up. The female was in possession of drug paraphernalia which was destroyed.

Crash with Injury

Police and EMS were dispatched for a vehicle crash vs. pedestrian. Upon arrival officers saw that the pedestrian that was hit was a City Street Dept worker who had been working on the roadway in a construction zone between two city trucks filling roadway cracks.

Officers learned that a vehicle was traveling eastbound on River St and started a left turn into the Spectrum Industries lot when that driver paused due to the presence of road repair. A second vehicle was traveling westbound and conducted an evasive maneuver to avoid striking the first vehicle that was now in its lane. When that vehicle conducted the evasive maneuver it struck the Street Dept worker. The worker sustained suspected substantial injures and was transported by EMS. The driver was cited for failure to yield right of way, resulting in bodily harm.

Drug Abuse

Officers were called to the above location for the report of a vehicle parked on the road with a female inside throwing things in the vehicle. Before arrival, the complainant called stating the vehicle left and then came back. Officers contacted the driver who denied driving. A K9 was called and it had a positive indication on the vehicle. A search was conducted and suspected fentanyl was located. The suspect was taken into custody for Criminal Operating while revoked, felony bail jumping, possession of narcotics, and obstructing an officer. Citations for failure to install IID and operating while revoked were faxed to the jail.

Drug Abuse

Officers were called to the above address for the report of a grey vehicle with no rear plate which struck a building and kept driving. Contact was made with the driver of the vehicle. When he was driving around the block, he stated the steering wheel locked up and he struck the garage. A probation search of the vehicle and house was conducted and different paraphernalia and drugs were located. Charges will be referred for Possession Methamphetamine, Possession of Controlled Substance, Unlawful Possession of Prescription, and Possession of Drug Paraphernalia.
