#### OWI & Domestic

Anonymous report of a person yelling at the above address. Contact was made with a female who stated a man hit her in the face. Officers observed him drive when he arrived on scene. He stated nothing physical had happened. He was evaluated for intoxicated and was subsequently arrested for domestic D/C, battery, and OWI 3<sup>rd</sup> and taken to jail.

#### Crash – OWI

Officers responded for a reported one vehicle crash on Park Ave. A witness saw a male with a blue checkered style shirt leave the vehicle and walk east. Officer saw the airbag was deployed on the driver side. Officers located a male that matched the description and was the registered owner of the car near the walking trail near Pumphouse Rd. He said his vehicle was stolen from the Dam Bar and was on the phone with his brother talking about it. Officers located a damaged vehicle at 210 Depot Street that had

a trail of fluid to the crash site. The suspect showed signs of impairment and was taken into custody for OWI 2nd, along with several citations. He refused blood draw and warrant was granted. He was taken to jail.
