#### **EMS Assist**

911 caller reported he had stabbed himself in the leg, near the femoral artery and had a substantial loss of blood. He started to lose consciousness and could not come to the door. Officers forced entry. He was found on the kitchen floor with substantial blood loss. Tourniquets were applied by officers. EMS arrived and transported the caller. NW Connections was notified for an assessment. Officers also made contact with neighbors but nothing suspicious was found.

## **Drug Abuse**

Report of a male sleeping behind the wheel while in a car. Contact was made with the male who displayed signs of impairment. SFST was completed and enough evidence was observed to arrest him for OWI 4th. During the search of his person a crack pipe was located. A vehicle search was completed, and drugs, cutting agents, and a scale were located. A blood draw was conducted and completed he was arrested and transported to jail for bail jumping, OWI 4th, possession of drug paraphernalia, possession with intent, and Operating after Revocation. Probation was contacted and a hold was placed.

#### **Speeding and Littering**

Officer stopped a male for Speed 18 mph over the limit. While issuing the citation the driver became upset and threw it out the window. The driver was asked to retrieve the citation and refused. The driver was advised if he did not collect the citation he would be cited for littering. The driver put the vehicle in drive and requested both citations be mailed to him.

# **Drug Abuse**

Officer conducted a traffic stop on a vehicle for unsafe lane deviation and non-registration of auto. The driver was eventually arrested for OWI. During the investigation a vehicle search was conducted locating drugs and drug paraphernalia. She was taken to jail for Operating while impaired (1st offense), possession of methamphetamine, and possession of drug paraphernalia and cited for Operating while suspended. She was verbally warned for Deviating from lane of travel and non-registration of auto.
