Drug Abuse

A female was seen riding a bicycle northbound on Bay St and made a westbound turn onto W Cedar St. She had an open bottle of wine in her hand as she rode the bicycle. Contact was made for riding the wrong way on the road and for city ordinance regarding open intoxicants. She consented to a search of her person and stated she had a hypodermic needle in her bra. She turned over the syringe which tested presumptively positive for methamphetamine. She was arrested for Possession of Methamphetamine and warned for the other violations.

Drug Abuse

Officers responded for the report of a female overdosing. The female was provided Narcan and eventually came to. A white Ford Edge was seen leaving the scene and was pulled over by officers. The vehicle was operated by a male who admitted to calling 911 after she had overdosed but left when EMS arrived on scene. She was transported to St. Joseph's Hospital by EMS. She told Officers the male had brought drugs to the residence that she overdosed on. A search was completed of his vehicle and his person with no weapons or contraband being located. He was arrested for a probation hold. Investigation continues.

Drug Abuse & OWI 3rd

An officer witnessed a vehicle fail to stop at stop sign near Kwik Trip East. The driver was revoked. He fled on foot and was located by officers in a backyard. He was arrested for OWI-3rd Offense, Possession of Cocaine 2nd+ Offense, Operating While Revoked, Failure to Install

Ignition Interlock Device, Misdemeanor Bail Jumping, and Resisting or Obstructing an Officer.
Citations issued for No Insurance, Possession of Open Intoxicants in Motor Vehicle of Driver and Passenger, and Failure to Obey Traffic Sign.
