Reckless Driving

Report of a one vehicle rollover crash without injury in Irvine Park near the Elk pen. The vehicle was driving recklessly through the park, fish tailing around corners at high speed. Videos were posted to Snapchat. The vehicle lost control around the corner, striking the fence, losing control and overturned. Vehicle was towed. The driver was cited for reckless driving and failing to maintain control.

Barricaded Subject/Death Investigation

Dispatch received a 911 call from a female who stated there was an intruder in her residence with a gun threatening her and himself. The female escaped through a window onto the roof and was able to jump to the officers below. Eau Claire Regional SWAT was requested to respond. Police negotiators attempted to contact the suspect. SWAT arrived on scene and made announcements asking the suspect to surrender peacefully. SWAT utilized their robot to search the residence and they located a male subject who was not moving. The coroner and investigators were able to confirm the male was the suspect in this case and was deceased. The initial investigation in this matter has led investigators to believe the gunshot wound was self-inflicted.

Mental Health

At 2:00 am Officers received a report of a male subject sitting on the ledge of the Hwy 124 Bridge. A CFPD patrol officer contacted the male who said he wanted to jump. EMS prepared for a water rescue. The officer was able to talk the man away from the ledge. He was transported to the police department where an assessment with NW Connections was completed. A safety plan was put in place with relatives.

Hit and Run, OWI 2nd

Caller reported a vehicle hit his vehicle at Main St and Park Ave and fled. He followed the other vehicle to Willow St. The driver walked into the apartment building and looked intoxicated. Officers contacted the driver of the striking vehicle. The driver was eventually arrested for OWI-2nd. The driver was cited for operating while revoked and hit and run. He also had drug paraphernalia on him during the arrest.

Check Person

Officer was flagged down near the above location by an adult female. She said she just wanted to thank CFPD for all the help they have provided her in the past and updated the officer on the positive progress she has made.
