## **Drug Abuse**

Officers were called for a female who was unconscious but breathing in the front yard of a residence. She had arrived with a male to look through the dumpster in the front yard. She then began overdosing and she was given Narcan. Inside of her purse was a jewelry box containing a white crystal-like substance. She said she saw a powdery substance on the counter at her residence and tasted it which caused the overdose. She was taken for medical clearance and then to jail for possession of methamphetamine, felony bail jumping, and a probation hold.

## **Domestic Abuse and Drug Abuse**

A male party reported a domestic incident where a female physically assaulted him and damaged his vehicle. Officers attempted having her exit the residence, but she failed to comply. Officers were eventually able to take her into custody. Through the investigation, more charges were substantiated against her and she was arrested for simple battery, domestic abuse, obstructing, damage to property, theft of movable property, possession of drug paraphernalia, possession of cocaine, possession of THC, and unlawful possession of prescription medications.

## **Assault**

Officers were dispatched to Klein Hall for a report of an intoxicated and aggressive male. Dispatch updated and advised Officers that the male had attacked one of the residents with a sword who now had a laceration wound. Staff then advised that he had fled to his camper. Officers arrived on scene and surrounded his camper with patrol cars. A high-risk contact was

conducted and he surrendered peacefully. He was taken into custody for 1st degree reckless endangering safety, battery simple assault and probation violation. The subject was transported to the Chippewa County Jail.

## **Juvenile Case**

Officers responded to a report of juveniles throwing rocks at passing cars on Court St at Prairie St. Upon arrival the officer met with two boys aged 12 and 6. They both attempted to run away from the officer when they saw him approaching but stopped when he got to the top of the Court St hill. The boys would not tell the officer their real names or where they lived. SRO's assisted with identification of the boys and their parents. The boys and parents were warned about throwing rocks at vehicles.
