### **Drug Abuse**

Officers were advised of a bus complaint alleging a M.S. and H.S. student were vaping on the bus. Upon interviewing the student, a vape pen was seized from the M.S student. This pen tested presumptively positive for the presence of THC. The student will be referred to juvenile intake for possession of THC. School to sanction as well.

### **Drug Abuse**

One adult passenger was arrested for Possession of Methamphetamine, Possession of Illegally Obtained Rx, and Felony Bail Jumping. The second adult passenger was on bond with a condition to maintain absolute sobriety and had been previously consuming alcohol and was taken into custody for Felony Bail Jumping. A small bag of meth was located on his person.

#### **Drug Abuse**

A K9 sniff was conducted on a vehicle at America's Best Value Inn parking lot and positive indication was given. Contact was made with occupants of room 140. The owner of the vehicle was on active parole. A search of the vehicle and other areas were conducted. The vehicle owner was arrested for Possession with Intent Amphetamine, Possession of Drug Paraphernalia, and a PO hold was placed. The second occupant was arrested for PTAC Possession with Intent Amphetamine 10-50g, Possession of Drug Paraphernalia, and Possession of THC.
