Domestic Assault

Officers were dispatched to an apartment for a noise complaint. Officers contacted the occupant who stated she was okay and did not want any help. After further conversation the female invited Officers inside. She stated she thought her husband had jumped out of the window while she was speaking to Officers. Officers were able to determine a domestic incident had occurred. He was later located inside of the apartment building and placed into custody. The suspect also had a valid warrant out of Eau Claire County.

Fireworks

Officers received multiple reports of fireworks going off in the area at 10:00pm. Contact was made with a two male adults. They admitted lighting the fireworks off. Officers warned them to stop or they would receive a citation. Shortly after more fireworks were lit off. The officer issued a citation for Discharging a Firework. At 2:00am more fireworks went off and officers were able to determine it was the same people as before and they were cited again.

Fight

A female called 911 and hung up. Officers made contact with her at the Sweeney's tavern and she had blood coming from her face. She said she did not know the name of the male that hit her but she advised she did not want to pursue charges as she came to Sweeney's in a fighting mood and got into a fight. Officers were not able to identify the other party alleged to be in the fight. She was warned and counseled on a number of issues.

Domestic Assault and Battery to Law Enforcement

Officers received a report of a physical domestic occurring at 103 West Canal Street. Upon arrival, Officers made contact with a male and several others. During the investigation the male tried to shut the door on Officers several times and then proceeded to fight with two officers on scene. He was arrested

for domestic battery, domestic Disorderly Conduct, False Imprisonment (3 counts), battery, battery to law enforcement (two counts), and resisting and obstructing officers.

Overdose

Officers were dispatched for a 44-year old male who was overdosing. Caller had administered two doses of Narcan prior to Officers arrival, and CPR was reported to be in progress. Officers arrived on scene and one dose of Narcan was administered by officers. EMS arrived and provided medical aid. The male woke up and stated he was fine.
